INTRODUCTION

About

Our goal is to provide skills and knowledge to an individual that is seeking a career as a heavy equipment operator. Whether you have no experience or are already an operator and looking to improve your abilities, HEOA is a path to help you reach your potential.

In addition to equipment operation, you will receive training on site preparation, excavation, digging techniques used in the field, dirt classifications, how to read blueprints, and safety regulations. Graduates from our heavy equipment academy are eligible for a variety of jobs in many industries such as oil, gas, railroad, waste disposal and recycling, and construction. Having a skilled trade makes your time at work more valuable. Skill trades are as important today as they have ever been, and there is a great demand for work in such fields.

Objective

Our objective is to produce heavy equipment operators that have the knowledge and skills to better, not only themselves, but their individual communities as well. Our program is also geared to help students who want to accelerate their careers and are looking for a leadership role. It's not uncommon for our students to work their way up to a foreman position in a relatively short amount of time.

Orientation

Student orientation is designed to give you the tools necessary to succeed at HEOA. Typically, orientation will take place on your first day. It's a good idea to try to arrive a bit early in order to familiarize yourself with the facility and it's a great opportunity to get to know your fellow students and instructors. During this time, we will also try to assess where everyone is in their current knowledge about operating, and try to address any questions and concerns you may have.

2025 Start Dates - CDL

New CDL classes start every week and are filled on a first come first served basis. As soon as a new seat opens up we reach out to the next person in line and fill that spot immediately. The first week of the program is designated for the "Theory" portion of the training class and can be completed remotely at your own pace. The remainder of the class is all hands training here at our academy.

2025 Start Dates – Evening Classes

Evening classes run 5:00pm – 9:00pm and are only available during the summer months and only for select programs. Programs covered include: Dozer, Excavator, and Loader. Duration is also increased due to the part time nature of these programs.

ATTENDANCE

Class Times

Classroom hours: Monday-Friday 8:00am - 4:00pm.

Operating time: Times vary as assigned by instructors

Excused Absences

Our policy is to excuse student absences for the following reasons:

- Illness or Injury preventing the student from attending class
- Death of a family member
- Other compelling verifiable circumstances beyond the students control

Students who request an excused absence must provide documentation to their instructor as soon as possible. Absences that do not fall into the categories listed above will be considered unexcused. Students who are absent from class are still responsible for any and all missed work; however they will be allowed to make up missed work, but be aware some skill assessments may require students to work over and stay after class in order to complete them.

Communicable Diseases

HEOA reserves the right to restrict school access to any student who has been diagnosed as having a contagious or communicable disease or virus. It is assumed that all students are free from any such illnesses, however, if any student knows or has reason to believe that he/she may be infected, that student must report this immediately to their instructors. Restrictions or Exclusions may be temporarily put in place to protect the welfare of all students and staff in accordance with state and federal laws and guidelines. Students may be advised to leave campus or return home immediately upon notification of a communicable disease or virus. Students may also be required to obtain documentation from their medical provider before being able to return.

Leave of Absence (LOA)

LOA request form and any supporting documents can be submitted to the administrator for approval. When a student is seeking to return to the program an evaluation may be needed to determine placement and restart date.

Makeup Time

Occasionally we offer extended hours after class, or even on Saturdays to makeup time that students have missed or if a student is on an improvement plan and needs extra help. The times vary and it is at the sole discretion of our instructors. This time may be used for class work or field work depending on the students needs. We highly encourage our students to take advantage of this time when it is offered.

Attendance Policy

Student Expectations

- 1. Sign in/out before & after class.
- **2.** If taking breaks, follow on/off times the instructor has set.
- **3.** Stay on task in assigned area.
- **4.** Complete the day by cleaning out equipment and getting it ready for the next day.
- **5.** Be present for at least 85% of the course
- 6. Take advantage of makeup time.

Anything outside of the above listed expectations is considered to be an attendance infraction.

Attendance Infractions

- **1.** One to fifteen-minute infractions will count as .25 hours.
- **2.** Infractions over fifteen-minutes will count as actual time.

If a student misses more than 15% of the course, the student may be dismissed.

Example: In our 8 week program if a student misses 6 days, this would be 15% of the program missed.

If a student is absent and has not called in for three consecutive days, the student will then be considered withdrawn from the program.

Legal Holidays

The following holidays will be observed: New Year's Day, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Friday following Thanksgiving Day, Christmas Eve and Christmas Day.

Inclement Weather Policy

HEOA will be closed due to inclement weather when the administration deems necessary. A notification will be sent out via group text to all students in the event we close. In instances where HEOA does not close, it's each student's responsibility to determine if safe travel is possible. If it is not possible, the student should contact their instructor to inform them of their absence. Closures due to inclement weather will not be counted as an attendance infraction.

HEAVY EQUIPMENT OPERATOR COURSE

- Must be 16 years old on or before the first day of class.
- A CDL is not required.
- Must be able to pass a drug test.
- Courses are anywhere from 2 weeks up to 8 weeks depending on the equipment you want to master.
- All tools and equipment required to complete the course will be provided by HEOA.
- This course is designed to prepare heavy equipment operators for work in oil, gas,

- railroad, construction, and many other areas.
- Students will demonstrate knowledge of theory, equipment and troubleshooting of equipment to be used.
- Students will also get the opportunity to learn how to properly spot and swamp for operators.
- Students will use common trade math. In the vocational setting, math is sometimes easier to comprehend when applied to physical objects.

- Students will be introduced to different dirt classifications, A, B & C, and OSHA shoring methods.
- Project plans Blueprints, legends, detailed drawings and symbols.
- After the student exhibits skills and control of each process, the instructor may allow the student to move to the next process.
- Each student during skills testing can progress individually according to the individual's skill with the direction of our instructors.
- Our tests are practical hands on equipment operation & obstacle avoidance tests.
- Students will demonstrate ability to operate each piece of equipment on site within OSHA code and follow proper digging procedures.
- Students shall wear proper PPE at all times.
- Students will get training on how to lead crews and will be given the opportunity to see what it's like to be in a foreman position.

- To graduate our course you must be able to complete all the tasks assigned to you at an efficiency rate of no less than 70%.
- Students will also be graded on the cleanliness of their work. Specifically ditching, trenching, bell holes, and grading.
- Local Contractors may visit from time to time and occasionally offer our students positions while they are still in school.
- Instructors may allow students to graduate early, but this is at the sole discretion of the instructor, and all skill tests must be completed with a passing score.
- Resume, interview and job placement assistance is provided at the end of the course.
- Upon course completion a student will receive a Certificate of Completion, provided they meet minimum skill requirements, as well as a wallet sized certification card.

Graduating

To graduate this program we're looking for 70% efficiency on all the equipment. We understand that you're just starting your career as an operator and we don't expect our graduates to operate like an operator that's been doing this for 20+ years. But we do expect to get you most of the way there. In our experience we know that if we can get you to a point where you're that good on the equipment, there's no doubt that you'll be able to hold down a job. Upon graduating, students will receive a certificate of completion, OSHA 10 Certification and a Heavy Equipment Certification Card.

Payment Policy

Upon enrollment, a student will be billed for the full cost of their chosen program. An invoice will be emailed to the student along with an acceptance letter. Physical copies can be mailed upon request. The program cost must be paid in full, or funding source(s) confirmed at least 2 weeks prior to the start date of the class. Students not able to complete the payment process will be moved to a future start date. HEOA accepts payments via credit/debit cards, check, cash or money order. Payments can be made online at anytime or over the phone during business hours.

Transfer of Credits

Heavy Equipment Operating Academy programs are determined by clock hours instead of credit hours. Therefore, HEOA does not issue credits. Transferability of HEOA's clock hours to another institution is determined exclusively by the receiving institution. No person can imply or guarantee that clock hours will be converted to credits to be transferable. As a vocational training program, it is unlikely that any credit will be given at another post-secondary institution that offers credits instead of clock hours for training received by HEOA. HEOA does not give credit for prior equipment training. All students begin at the beginning of their program curriculum and progress through the entire curriculum, regardless of prior heavy equipment knowledge.

Housing

Not everyone lives within driving distance from our campus; however, we've got you covered. We have several rental agreements from nearby landlords that have agreed to house our students at super affordable rates. All of these homes are fully furnished and we pay for all the utilities, including electric, water and gas! Here are a few questions we are often asked about our dorms.

Q. How much does it cost?

A. Our dorms are only \$300.00 per month

Q. Will I have my own room?

A. For \$300.00 per month you will have a roommate. If you wish to have a room all to yourself the cost for that is \$600.00 per month.

Q. Is there any sort of deposit?

A. Yes. We do require a small non-refundable security/cleaning deposit of \$100.00

Q. Can I bring my Pet?

A. No, but we do make exceptions for service animals

Q. Do you provide food?

A. No, you will be responsible to provide your own meals; however, you will have access to a fridge, stove, oven, microwave, and all of our cooking utensils.

Q. What should I bring with me?

A. We recommend bringing appropriate clothing along with toiletries, towels, and laundry detergent. Bedding is available; however some students prefer to bring their own.

Dress Code & PPE supplied by student

Students supply their own gloves and boots. No tanks or muscle shirts permitted. Good pants and good boots. Closed toed shoes are a must. Avoid loose fitting clothing. Loose clothes may get caught and snagged on tools and equipment. If proper dress code is not followed, students will incur an attendance infraction until they return with proper clothing.

POLICIES FOR STUDENTS RECEIVING VA BENEFITS

Standards of Progress for VA Students

Evaluation of progress of VA students will be conducted by the school's evaluation policy schedule. Students with a minimum of **70%** academic average and **75%** attendance will be considered making satisfactory progress until the next scheduled evaluation.

In order for a student to be considered making satisfactory progress the student must meet both attendance and academic minimum requirements. Students receiving VA benefits who fail to meet minimum progress and attendance requirements will be placed on **probation** for 30 days. At the end of the probationary period, the student's progress (academic and attendance) will be re-evaluated. If the student is meeting minimum requirements, the student will be determined to be making satisfactory progress and will be considered off Probation.

Suspension/Withdrawn/Termination

If the student fails to meet minimum requirements in either academics or attendance, the school's certifying official will submit a 22-1999b effective on the last day of probation.

Reinstatement of VA student's educational benefits

Once VA student's educational benefits has been suspended and after 30 days and the student is meeting the minimum standards of progress, the school's certifying official will submit a 22-1999.

Refund Policy

In the event a veteran fails to enter the course or withdraws or is discontinued a refund will be based on a pro rata refund of the unused portion of tuition, fees and charges. This refund will be returned promptly as required under 38 CFR 21.4255

Refunds:

Refunds will be made based on the chart below within 40 days of withdraw.

Prior Credit

It is the policy of this institution that an evaluation of previous education and training will be conducted, appropriate credit granted, if applicable, the institution's duration in the course will be shortened proportionately, and that the Veteran's Administration and the student will be so notified. VA credit will be given for prior training for veterans and eligible programs.

EVALUATIONS

Explanation of Evaluation and Completion Requirements

To satisfactorily complete an HEOA program, students must meet the following requirements:

- Complete 85% of required training hours
- Maintain daily productivity rate of at least 80%
- Score 70% or better on all skill evaluations
- Maintain at least an 80% or higher in safety
- Complete OSHA-10 Training

Student progress folders are maintained and available for student review at any time. Students who fall below these standards may be placed on an improvement plan.

Academic Standards and Grading System

Student progress binders are maintained and available for student review at any time. Grades on skills will be recorded as a percentage. Students must maintain 70% or above on skill tests, meet 80% or more of daily

production and maintain a classroom GPA of 2.0. If a student falls below those requirements they will be placed on an improvement plan. Overall course score is made up of 20% Classroom GPA, 40% daily production and 40% skill evaluations.

Unsatisfactory Performance

Any student who fails to meet the standards discussed above will be removed from the course. HEOA will then notify the student's funding agency to interrupt the student's educational benefits if the student withdraws or is dismissed.

Performance Monitoring

An audit will be conducted at each program midpoint by the instructor. If safety, production, or skill evaluations fall below the minimum satisfactory requirements, the student will be placed on an improvement plan and monitored. Student progress is monitored daily. Students are notified on their placement on an improvement plan if they are not making satisfactory progress. If a student falls below any of the standards at any time, they may be dismissed.

Student Improvement Plans

Students who fail to maintain standards may be placed on an improvement plan in order to bring their attendance, safety, production, or skill evaluations up to the minimum standards. A student improvement plan is considered a probationary period to allow a student the opportunity to meet minimum standards. Students who do not follow their improvement plan, or who do not progress, may be dismissed from the program.

Insubordination

By completing an enrollment agreement, students acknowledge that the student catalog is accessible to them and they agree to abide by the school policies and procedures as stated. Failure to comply with the directives of a school official or other authorized guidelines is considered insubordination. Refusing to cooperate with efforts made to help the student adjust to their chosen program of study will be considered insubordination.

Job Placement Assistance

HEOA does not guarantee employment or wages upon program completion. Students complete job placement assistance training as part of each program's curriculum. Students are provided with resume assistance, application assistance, and assistance making calls inquiring about potential jobs. Students will demonstrate the ability to apply for jobs, speak to recruiters and HR personnel, schedule interviews, and begin employment. Students are required to complete and turn in a job log during this training.

Waivers are available for students who have a job lined up or who do not plan on obtaining employment within 30 days of completing the course.

Questionable Honesty

Any form of dishonesty, including but not limited to cheating, plagiarism, falsification of attendance, forgery, and/or lying to school officials, is prohibited and may result in dismissal. HEOA reserves the right to immediately dismiss a student based on the individual circumstance. The rules outlined above are a courtesy offered to a student and are not guaranteed in every situation.

SAFETY

A safety session, along with safety tests, and safety plans are part of our core safety curriculum.

OSHA-10

Students are also required to complete OSHA-10 training as part of their program curriculum. Students will log in and create an account during orientation. Students must complete the OSHA-10 training in order to graduate the course. Exceptions will be made for students that already possess valid OSHA-10 certification.

Safety

Additional safety equipment is provided by HEOA and is included in all of our courses. We take safety very seriously, as such we cover all of the OSHA safety guidelines associated with operating heavy equipment as well as all the equipment manufacturer warnings and all of our machines are equipped with roll over protection.

Horseplay

Horseplay around heavy equipment poses a significant danger and should be strictly avoided to ensure the safety of all students. Engaging in such acts near heavy equipment can lead to severe accidents. It is crucial for students to recognize the hazards associated with heavy equipment and to prioritize safety by adhering to the established guidelines and maintaining a respectful, focused environment in areas where machinery is present. Furthermore, students caught engaging in horseplay may be placed on an improvement plan or face disciplinary action, depending on the severity of the activity.

Safety Score

All students begin the program with a 100% safety score. Each safety violation will result in a 10% grade deduction. On the first violation the student will be required to complete an essay documenting 3 cases of bodily injury or death due to specified safety violations and present it to the entire class at the next morning safety meeting. On the second violation, depending on the severity, the student can be suspended for 1-3 days or dismissed at the discretion of the lead instructor. Upon receiving a third safety violation a student will be suspended for a minimum of 3 days and may be dismissed at the discretion of the director and lead instructor. The attendance policy applies while a student is serving a suspension.

CODE OF CONDUCT

- Students are expected to be respectful of others on and off campus.
- Disorderly conduct will not be tolerated. The focus of students needs to be set on learning the trade. Any disturbance that draws attention away from that is prohibited.
- Obscene language or images are not allowed on campus.
- Students will keep their work areas clean and orderly.
- Repeated violations of the above listed offences may result in dismissal.

Sexual or Racial Misconduct and Harassment

Will not be tolerated. Disciplinary action will be taken for these offences up to and including dismissal from the program.

Drug and Alcohol Policy

- Use of drugs or alcohol on campus is prohibited.
- Drug or controlled substance paraphernalia is prohibited on school campus.
- Students may be subject to drug and alcohol tests at any time during the program.
- Violation of the drug and alcohol policy or a positive test will result in dismissal.
- Safety violations may result in an immediate drug test. Failure to pass a drug screening will result in dismissal from the program.

Theft

All students are required to report any theft or vandalism to the school. Failure to do so may result in disciplinary action. HEOA may also contact the county sheriff's office to investigate. Any theft or vandalism will result in dismissal.

Disciplinary Action

For each offence, a Student Incident Form will be completed by the instructor. The student can write a response. The Student Incident Form will be signed and dated by both instructor and student. The form will be placed in the students file and a copy given to the student.

- First offence Student Incident Form placed in students file.
- <u>Second offence</u> Student Incident Form placed in students file. A suspension may occur at the instructor's discretion.
- Third offence May result in student dismissal.

Time lost to suspension will count as an attendance infraction.

The School administrator has the authority to dismiss a student who violates school policies.

STUDENT RECORDS

Access to Student Records

Instructors and/or students are permitted to view their student folders, including enrollment information, payment information, invoices, and skill tests, at any time upon request.

Maintenance and Retention of Student Records

HEOA shall record all student transcript records indefinitely. These will be kept in hard copy and/or electronic form. Enrollment information, payment information, production sheets, etc. will be maintained for a least three years following completion, dismissal, or withdrawal. These will be kept in hardcopy until electronically scanned and backed up.

Student records shall be open for inspection by authorized representatives of the Arkansas Department of Higher Education or the Department of Veterans Affairs. HEOA may retain a student's academic transcript, certificate of completion, or any pertinent record if a student's financial obligations are not paid in full.

Transcript Request

Students in good standing can request a copy of their transcript from the Director.

COMPLAINT OR GRIEVANCE POLICY

All student complaints should be first directed to the school personnel involved. If no resolution is forthcoming, a written complaint shall be submitted to the administrator of school. Whether or not the problem or complaint has been resolved to his/her satisfaction by the school, the student may direct any problem or complaint to the Arkansas Department of Higher Education 423 Main Street, Little Rock, AR 72201.

Refund Policy

The initial \$250.00 deposit is nonrefundable, however, this deposit can be transferred to a later start date at any time, provided there is adequate space available in the class. Withdrawal (written) or termination prior to start date the student will receive a full refund of tuition, tools and materials. On or after start date only the tuition is eligible of refund. Rates are as follows:

- 0-5% of course completion the student is eligible for a 90% tuition refund.
- 5-25% of course completion the student is eligible for a 75% tuition refund.
- 25-50% or more of course completion the student is not eligible for tuition refund.
- Over 50% of course completion no refund is available.

Example: In our 8 week program if a student dropped out after 8 days, they would only have completed 20% of the program. Based on the chart above, this would result in a refund of 75% of the tuition. (Cost for tools, deposit, books, etc would not be refundable.)

Refunds will not be calculated or issued until the withdrawal process has been completed. Students who are dismissed by HEOA will also be subject to this refund policy. In addition HEOA will notify a student's funding agency upon their cancellation, withdrawal, or dismissal.


FACILITY

QUESTIONS & ANSWERS

Q: Will you help me get a job?

A: Yes, We do have an excellent job placement program. We even invite contractors in to visit and recruit students directly out of our school, and, although we can't guarantee employment, our school has a job placement rate over 90%!

Q: What if I am out of state?

A: We've got you covered. We offer housing for all of our students and it's extremely affordable, only \$300 per month!



We also pay for all the utilities and our houses are all fully furnished! All you need to bring is your clothes, toiletries, and bedding. We even have transportation available for students who fly in.

Q: Is this certification good in every state?

A: Yes! We've placed students in jobs as far north as Alaska and even down south in Florida. We have relationships with contractors across the country and we will work with you to find you employment in whatever state you want to work in.

Q: Is financial aid available?

A: Financial aid options are available. We have staff in our admissions department who can assist you and help walk you through the process of securing grants, scholarships, and student loans to fund this program.

Q: What if I have bad credit?

A: Having bad credit or no credit can make it a bit more challenging to secure financing, but there are resources out there

Q: Is there career advancement in this industry?

A: Yes! We aim to produce students who are not only fully capable operators, but our program is also geared to teach students all the skills necessary to become Foremen and Superintendents later in their career.

Q: Am I too young/old to be an operator?

A: No. The average age of an operator according to the Bureau of Labor Statistics, the average age of an operator is 45. We've had students as young as 17, and as old as 67 come through this class and be successful.

Q: Do you offer online courses?

A: No, this is a hands-on course. All of our training takes place behind the controls of real life equipment.

Q: What if I struggle operating or academically?

A: If we notice a student struggling on a particular piece of

equipment or struggling with some of the book work, we may approach them and offer additional time after hours to help them catch up to the rest of the class.

A: No! You do not need a CDL to operate heavy equipment. However, having a CDL helps when seeking employment and may result in a higher paying job offer.

A: Yes, if you were to have a CDL for example, this would not only allow you to operate the equipment, but transport it as well. Many contractors are willing to pay more for an operator with this license. Here is a list of just a few skills and credentials that marry extremely well to this trade:

Q: How long is the Heavy Equipment certification good for?

A: Our certification card is good for 3 years from the date you graduate the course.

Q: How do I renew my certification?

A: Easy. When you're ready to have your license renewed just contact us. We have a 1-day safety refresher course and we cover any new OSHA / MSHA rules and regulation changes. Once that's done you'll be issued a new license and you're good for another 3 years.
